#### **Guest Participation**

Old 3C Rd. and Nick Ridenour owner of the Galena Diner spoke to Council about wanting to add a community garden at Miller Park in the green open space inside the walking path. They want to use the community garden as an opportunity to educate people about gardening and different foods, bring the community together and build positive relationships. David Simmons suggested that Cassie talk with Dave and June Foley, who live on Walnut Street adjacent to Miller Park, to learn about their measures taken every year to protect their extensive garden from deer foraging.

John Hower, Rinehart-Walters-Danner Insurance presented the annual insurance renewal information to Council. He reviewed the new policy and answered questions presented by Council.

Ken Molnar, Solicitor reported to Council that he is working on reinstating the Galena Foundation to be able to accept donations for the Village. Hopefully this will be completed by the end of the year.

#### Village Administrator's Report

Village Administrator Jeff White reported that the Village did not receive grant money from the Preservation Parks of Delaware County for the drainage issue at the Walnut Creek Trail. The Joe Walker Road paving project has been completed and we should receive an invoice before the end of the year. Hill's paving replaced crumbling pavement on Rose Ave./Quinn St. and crack filling was performed on Heathermere, Tristaine Ct., Zoar St., and Melimare Dr. Arrangements have been made for Adam's Tree Care to hang the lights on the spruce tree on the Village square in time for the December 5<sup>th</sup> tree lighting event. Mr. White attended the Delaware County Friends of The Trail meeting. The DCFT donated \$1,137.70 to have signs made for the Thomas W. Hopper Legacy Trail and a replacement historic sign for the Galena Brick Trail. Mr. White had the signs to show Council.

#### Mayor's Report

Mayor Jill Love presented a Proclamation to Reggie Mullins. Planning and Zoning continues to work on the Master Plan. There are still active talks with Romaneli & Hughes on the Blackhawk Golf Course and Wright Farms. Arrowhead Golf Course is actively for sale and the Village has been approached by several developers. Berkshire Campgrounds is also for sale. The Village has established a new Development team consisting of Levi Koehler, Mark Rufener, Jeff White, Bill Vance, Ken Molnar and Jill Love.

#### **Fiscal Officers Report**

Fiscal Officer Suzanne Rease reported that there were 8 new residents and one cemetery plot sold. The Village currently has 440 sewer accounts, and the interest earned for August was \$265.19.

**Code Compliance Report** 

Levi Koehler's report stated that Storm Water inspections have been conducted at the Retreat at Dustin, and Phase 2 construction is underway. Arrowhead Lake Estates Phase 2 construction is underway, and Mark Rufener and Levi have done storm water inspections. Miller Farm engineering has been approved by the Planning and Zoning Commission. All mylars for phase 1 have been signed. The Development Agreement is under review by Village staff. Addresses have been assigned for phase 1 and a meeting with Homewood is scheduled for after Thanksgiving. At 51 Middle St construction has begun. Developer for Vans Valley/ Joe Walker is preparing documents for initial submission. The engineering is ongoing at 1811 S. Galena Rd.

#### Wastewater Treatment Plant Report

Brian Rammelsberg's report stated that there were no violations for the month. There were 10 new sewer taps for the month. The raw pump 1 at the Columbus Street Lift Station had to be repaired. The foam at the plant has gone down to a very thin layer. The chemical feed system will need an emergency shower installed before the chemicals can be delivered and the permit for the plant was renewed.
