Minutes of March 24, 2025 Council Meeting

Zach Hopper made a motion to adopt the minutes of the March 24, 2025 Council meeting Gillian Doucette seconded the motion and the motion passed unanimously in a 6-0 voice vote.

Delaware Public Health Department

Kelsey Kuhlman, Program Manager with the Delaware Public Health District introduced herself to Council. She reported that the Community Shred Day is May 3, 2025 from 9am -12pm, the Spring Clinic Tour featuring the walk in mobile clinic will be in Sunbury Monday May 12, 2025 and the Walk With Ease a 6 week free exercise program that combines education with a walking program.

Public Participation

Mary Howard, 1765 S. Galena Road commented that at the last few meetings there have been discussions about raising the Administrator's spending limit which she felt seemed high, so she reached out to local entities to see what their limits were. Berkshire-\$2,500 Sunbury-\$5,000 Genoa-\$10,000 and Orange-\$10,000. Also, she commented that shouldn't Council be involved in the decision of the best contractor for work to be completed?

Mayor's Report

The Galena/Sunbury/Berkshire Joint Recreation District Exploratory committee was seated and sworn in April 3rd. The Village is expecting Romanelli and Hughes to submit a formal application with in the week. Numerous grant submittals. The Growth Strategy document was posted to the website and modifications were made to page 30 concerning "Middle Housing".

Council President Report

Council President, Gillian Doucette mentioned be approached about a memorial buckeye tree in Miller Park, which will be considered after the building of the Pavilion and she has also been asked about additional playground equipment for older kids at Miller Park which can be looked at in the future. At the Big Walnut Civic meeting it was brought up about municipalities donating to the fireworks display, Ms. Doucette asked Council to consider making a donation and having legislation at the next meeting.

Administrative Report

Tom Marshall, Village Administrator, reported that we are now using YouTube for broadcasting and recording meetings. The BWC safety violations have been corrected at the Village Hall. The Village has applied for a federal grant for Walnut St. Phase IV and Village Square safety improvements. Big B Concrete will be starting on the crosswalk and sidewalk project in May. Fence installation on Big Walnut Creek Bike Trail is complete. Sewer Capacity Fee Study is underway.

Fiscal Officer Report

Fiscal Officer, Michelle Dearth, reported that all quarterly reports were completed and submitted. The annual SLFRP report having to do with CARES Act money received was completed and submitted.

Zoning Officer Report

Matt Shock's report stated that the Blackhawk Phase-D inspection and maintenance agreement for the detention basin has been signed by the HOA and KEM will verify all remaining punch list items have been completed and then the final acceptance of the subdivision can be completed. Miller Farm section 1 public infrastructure is complete up to the pump station, pump station construction is ongoing. Inquiries have begun on individual construction permits for 32 homes. Miller Farm Section 2 improvement plans for section 2, phases A,B, and C have been approved and construction is underway. Miller Farm Section 3A had first submittal package received. Planning and Zoning had no comments and KEM comment letter was relayed to EMH&T.
