On June 24, 2024 the Village of Galena Council meeting was called to order at 7:00 p.m. in Council Chambers of the Village Hall, 109 Harrison St., by Mayor Kinnell.

**Minutes of May 20, 2024 Council Meeting**

Chris Durrence made a motion to adopt the minutes of the May 20, 2024 Council meeting. Kathy Krupa seconded the motion and the motion passed unanimously in a 5-0 voice vote.

**Guest Participation**

James Golden, from Pavement Management presented information from the road study that his company prepared for the Village of Galena.

Jennifer Wilson from the Delaware Public Health District updated Council that the office in Sunbury is officially closed. A bus will be travelling around to different locations in Delaware County for mobile vaccinations. Bingocize is coming to Source Point, it is a 10-week exercise/health program in a bingo game format.

Dave O'Neil, 241 Harrison St. representing the Historic foundation reported that the signs are in and wants guidance as to where the signs should be placed. Ted Roshon will assist with this project.

**Mayor's Report**

Mayor Kinnell reported that rumble strips have been delivered and will be installed in the next few weeks. The park dedication is Friday June 28, 2024. Mayor Kinnell has had discussions with Chris Bauserman, County Engineer about moving 55 mph sign on Old 3C closer to Plumb Rd. Going south also discussed the thick vegetation on Sunbury Rd. near Vans Valley and about the idea of a flashing stop sign or slow sign at West St coming into the square from Old 3C. Mayor Kinnell explained what to expect on the Historical Preservation there will be a first reading of a Demolition moratorium, establishment of a Historic Commission through zoning and a public awareness effort.

Mayor Kinnell asked Council for a motion to appoint Seth Everitt to the Planning and Zoning Commission.

Mayor Kinnell asked Council for a motion to approve Engineering and Design only, at a cost of approximately \$8,500.00, for the crosswalk directly from the Coffee Vault to the square as previously discussed.

Kathy Krupa made a motion to approve Engineering and Design for the crosswalk directly from the Vault to the square. Mike Fry seconded the motion and the motion passed unanimously in a 5-0 voice vote.

**Administrator’s Report**

Interim Chief Administrator, Tom Marshall reported that the Blackhawk Estates final acceptance is pending. The Force main for Miller Farm Subdivision is nearly complete. Working on filling vacant positions all jobs have been advertised. Need to develop Maintenance plan for roads, parks, buildings, grounds and cemetery.

**Fiscal Officer Report**

Fiscal Officer, Michelle Dearth reported that 206 sewer refunds were completed and mailed out. Also, working on finalizing all paperwork for the playground grant, completing the estimated revenues and levy budget estimate and the MORPC salary survey.

**Payment of Invoices for June**

Chris Durrence made a motion to pay invoices for June. Kathy Krupa seconded the motion and the motion passed unanimously in a 5-0 voice vote.

**Approval of Financial Statements**

Kathy Krupa made a motion to approve the financial statements for June. Chris Durrence seconded the motion and the motion passed unanimously in a 5-0 voice vote.

**Code Compliance Report**

Levi Koehler’s report stated that Blackhawk Phase D has no remaining lots and inspections will conclude when the last remaining lot is seeded or sodded. The Miller Farm project has been approved by Council. Phase 1 begins with the force main under Big Walnut Creek. Construction has begun. The Zoning Inspector completes daily inspections of the work along with the engineering inspector. Division 7 is constructing a new office building, monthly storm water inspections have been completed and the sewer connection on Holmes St. has been completed. A list of property maintenance issues is being compiled and new violations will be sent out soon.

**Maintenance Report**

Ted Roshon’s report stated that there was full burial, mowing and trimming throughout the Village and working on removing the dirt from the playground and preparing for the ribbon cutting at Miller Park.
