Minutes of August 25, 2025 Council Meeting

Kathy Krupa made a motion to adopt the minutes of the August 25, 2025 Council meeting. Pete Casuccio seconded the motion and the motion passed unanimously in a 5-0 voice vote.

Delaware Public Health Department

Kelsey Kuhlman, Delaware Public Health District reported that the Fall Mobile Clinic will have multiple stops in Delaware County, there is a Drive -Thru clinic at the Delaware Health District on Monday Octiber6, 2025 from 4-7 pm, a First Responder Flu Clinic on October 17, 2025 from 8-10am at the Genoa Township Fire Station and there has been an outbreak of Hand, Foot and Mouth.

Mary Howard, 1765 S. Galena Rd. asked Council about the curve from Van's Valley Rd. to Jow Walker Rd. if there is plans to fix it. Mayor Kinnell responded that there is a lot of discussions and that the County is in control as to how this will be corrected. Ms. Howard also inquired about any plans to address the changes

that residents requested from the Arrowhead hearing. Pete Casuccio responded that it will be discussed in the elevation package.

Charles Krisak, 798 Atlatl, commented that showing elevations doesn't enhance the Village, where is the brick? Mayor Kinnell responded that Romanelli & Hughes is flexible and Council will need to make these decisions.

Annette McMurray, 3690 Worthington Rd asked if safety is going to be addressed with the proposed Arrowhead Development? Council discussed this at great lengths, with no definitive answer to the question.

Council President Report

Councilman Pete Casuccio reported for Council President, Gillian Doucette that she is excited about the Pavillion project and that there will be a meeting soon with the Retreats to discuss the private road signs.

Fiscal Officer, Michelle Dearth, reported that the Finance committee met on September 17, 2025 to discuss 2026 budget. Zoning Officer Report

Matt Shock's report stated that. Miller Farm section 1 public infrastructure is complete up to the pump station; pump station construction is ongoing and final zoning inspection was completed 8/28/25. 24 of 33 parcels are currently in some stage of the permitting process. Columbia Gas has completed the main gas line installation, and they've obtained permits for the service lines for each house. Miller Farm Section 2 improvement plans for section 2, phases A,B, and C have been approved, and construction is underway, ROW permits for Columbia Gas installation (all sections 2 phases) have been issued. Miller Farm Section 3A construction plans have been approved and construction is underway.
